## Regular Meeting of the Dorset Select Board August 17, 2017

Present: Henry Chandler (Chairman), Megan Thorn, Jack Stannard, Liz Ruffa, R. Gaiotti (Town Manager)

Absent: Tom Smith

Also, present: Mary Rita Manley, Sal Tassone (ITV Fest), Philip Gilpin, Jr. (ITV Fest), Martha Hamilton (ITV Fest), Jean Kingston, Ed Tanenhaus, Bo Thorn, D. Green, Joan Menson, Robert Menson, Allan Sullivan, Greg DeLuca, Tyler Yandow (Zoning Administrator)

H. Chandler, Chairman, called the meeting to order at 7:05 p.m.

### Approve Minutes of July 18, 2017 & August 2, 2017

M. Thorn moved and L. Ruffa seconded to approve the July 18, 2017 minutes as presented. J. Stannard amended the motion saying that the Board cannot make decisions in Executive Session and “No decisions were announced” should be removed. M. Thorn seconded the amendment. Motion carried 3-0.

M. Thorn moved and L. Ruffa seconded to approve the August 2, 2017 minutes as presented. Motion carried 3-0.

### Public Comment

J. Kingston noted that the Town report lists the Select Board meetings are to be held on the third Tuesday of each month at 7:00 p.m. She stated that this is the fifth time that the Board has changed to meeting to a different day and wondered how long this pattern would continue. H. Chandler responded that the Board are all busy people with other commitments along with summer scheduling conflicts. They will try to improve, but there is no guarantee. J. Kingston has two other points to cover under the noise ordinance item.

D. Green had questions about the Owls Head Town Forest and the Quarry. R. Gaiotti noted that he had not forwarded her email to the Board yet, but would be doing so shortly.

### ITV Fest Update

Phil Gilpin, Jr., Greg DeLuca and Martha Hamilton were present at the meeting

to represent the ITV Fest (Independent Television Festival). The ITV Fest is a one week event for independently produced television content to be held in Manchester from October 11<sup>th</sup> to the 15<sup>th</sup>, 2017. This event is similar in nature to the original Sundance Film Festival and will have screenings and workshops. Eight hundred people are confirmed and three hundred more are expected to attend this event. There will be shuttle buses from Manchester to Dorset so the attendees can experience Dorset – the Village Green, music on the Village Green, hayrides, trail hiking, music, Dorset Union Store, Dorset Historical Society, HN Williams, J. K. Adams, etc.

### **Village Center Designation**

Questions arose about the map included in the SB packet for tonight and R. Gaiotti responded that T. Yandow and the PC revised the previous map to include everything outlined in red which includes all the traditional establishments that program looks for, such as churches, libraries, museums, general stores, etc. M. Thorn wanted to make sure that the program that involves Act 250 exemption is not included in the current designation program and T. Yandow responded that they are two different and completely separate programs. M. Thorn moved and L. Ruffa seconded to approve and sign the August 10, 2017 Village Center Designation Letter as presented. Motion carried 3-0.

### **Owls Head Hill Lane ~ Mary Rita Manley**

M. Manley stated that she is a long time resident of Owls Head Hill Lane which was originally a log road, but has been greatly improved over the years. There are 26 parcels (22-24 homes) on this road including an extension to a private road. M. Manley asked if the Town would consider taking responsibility for the approximate one mile road as it is very populated. The residents wanted to know from the SB members if it was worth the road association's time to do all the engineering, surveys, etc. to make sure the road is up to Town standards. H. Chandler asked what the cost of maintaining the road was and M. Manley responded approximately \$15,000 per year. H. Chandler stated that it would be inappropriate to give a response tonight without further research due to the significant precedent setting nature of their response. It was the consensus of the Select Board members to do further research (subdivisions regulations, Town Plan, road standards, & similar roads).

### **Noise Ordinance Discussion (Continued)**

First Public Hearing was held in June 2017 and a second Public Hearing is scheduled for September 19, 2017. H. Chandler read T. Smith's email regarding the noise ordinance aloud to the audience (copy attached). It was the consensus of the SB members (with no comment from J. Stannard) to postpone the second Noise Ordinance Public Hearing until October 2017 out of respect for T. Smith's absence tonight and in order to have SB discussion at the September meeting.

M. Thorn added to the noise ordinance dated 7/17:

- Article II ~ Goal, last sentence add the word “directly” (*In furtherance of this goal, if a person disturbed by a loud or unreasonable noise can identify the source of the noise, it is suggested, but not required, that the person contact the offender directly to allow a reasonable opportunity to correct the violation voluntarily.*)
- Article IV ~ Exemptions, #10 ~ add the word “Church” and remove the last four words ~ *Bells: The playing or ringing of Church bells or chimes.*

M. Thorn brought up the topic of having a decibel guideline and using decibel meters to monitor noise levels, but noted that decibel readers used on cell phones are not accurate. J. Stannard was against decibel meters. H. Chandler felt meters could be part of the process of enforcement and L. Ruffa agreed with J. Stannard. The discussion of decibel meters was tabled. J. Stannard stated that if the Vermont State Police or Bennington Sheriff were not available, then the Select Board members or Town Manager should be called as backup to law enforcement. M. Thorn and H. Chandler did not agree with involving the SB members or Town Manager in the middle of enforcement. H. Chandler requested that all noise related correspondence be made part of the public record with the minutes.

J. Kingston noted that she lived 1,000 feet north of the Barrows House and they heard the last event at the Barrows House, but not to level to make a phone call. She felt that the problem of excessive noise is due to the thumping bass along with screaming for prolonged periods of time. It was suggested that the Board separate the noise issue into two categories: a one-two hour event with music and alcohol and a three-six hour event with over 75 people remove the amplified music and alcohol. Permits would be required for the longer events; they couldn't exceed 11:00 p.m. and include the cost of a Sheriff in the permit so they are present during the event. J. Kingston also suggested printing cards with the pertinent noise information to be tacked up around Town along with making complaints to the Liquor Authority.

E. Tanenhaus stated that the Select Board knew that a large event was going to take place at the Barrows House, but didn't protect the residents as law enforcement was not available that night. He suggested that an alternate trained law enforcement presence be available to sit out front and the Town could pay for his services with the speeding and DUI tickets he issues. H. Chandler responded that the issue does not have anything to do with making money from tickets and the Vermont State Police and Bennington Sheriff do not always have staff available to handle all their calls.

D. Green requested a clarification of waiver fee as used in the Noise Ordinance. M. Thorn explained that a waiver fee is when a ticket is issued and the offender chooses to pay the fine without going to court so a waiver fee is collected. If the

offender chooses to go to court, the fine is higher. E. Tanenhaus asked the SB to ask Sgt. Jesse Bravata about it being appropriate to make first contact with an offender as he did not feel it was a good idea.

All noise related correspondence is attached.

#### **Mad Tom & Route 7 Update (Continued)**

R. Gaiotti reviewed the updates covering: no parking signs on Route 30; Route 7 radar sign installation; AOT meeting on August 9; and final Route 7 intersection review may be available in the fall.

#### **Manchester Rescue Squad Lease**

M. Thorn moved and J. Stannard seconded to approve and authorize H. Chandler, as Chairman, to sign the Manchester Rescue Squad Lease Agreement as presented. Motion carried 4-0.

#### **Finance Report**

R. Gaiotti reported that the delinquent taxes are \$203,025 and that the draft FY17 audit showed a small surplus. The Dorset Town taxes are due on September 12, 2017.

#### **Manager's Report**

R. Gaiotti reviewed:

- Highway work
- Dorset Fire District support
- VYCC and trail building
- Lt. Governor hiked the OHTF trail
- Event held for the Governor at the Dorset Historical Society
- Quarry meeting (River Conservancy) update

#### **Other Business**

1. M. Thorn asked if the Town Attorney has reviewed all the Town ordinances and R. Gaiotti answered that he has the copies, but has not responded yet. R. Gaiotti suggested the possibility of having all Town ordinances updated and arranged into one document.
2. It was the consensus of the Select Board members to approve and sign the Errors and Omissions correction for dividing 4.78 acres into two parcels of 2.06 acres and 2.72 acres for 2620 and 2648 Dorset West Road.

M. Thorn moved and L. Ruffa seconded to adjourn the meeting at 8:45 p.m.  
Motion carried 4-0.

Hi Henry,

Hope your anniversary celebration is a good one.

I am sorry to miss the Aug 17 SB meeting because I have to take our daughter to the airport to return to North Carolina so I am taking you up on your willingness to express these comments on my behalf at the meeting.

### General comments:

Given the widely disparate (accurate and inaccurate) comments after the last wedding, it is clear that regardless of what restrictions a noise ordinance includes, a core group of people who do not meet the definition of "reasonable persons of ordinary sensitivity" will continue to object as long as weddings are held at the Barrows House. I think it makes sense to go ahead with a noise ordinance but people need to understand that it does not mean there will be no noise.

A way to abate the noise coming from weddings with a tent would be for the Zoning Board of Adjustment to issue a waver to the Barrows House to construct a 4,000 square foot event barn. This would go a long way toward solving the problem. At this point it is not clear that Steve Bryant would construct an event barn even if a waiver were issued. I realize, given the history of zoning changes and the members of the ZBA, that this not a likely option. If there were interest by the neighbors in actually addressing the issue it should be pursued.

### Specific comments:

## ARTICLE VI. PROCEDURE, ENFORCEMENT AND PENALTIES

There needs to be more clarity on who (if anyone) besides a law enforcement officer is authorized to act as an "Issuing Municipal Official". I think it makes sense for a law enforcement officer to issue a citation that the ordinance is being violated. I don't see that the law enforcement officer would be the one to "prosecute" the complaint.

There needs to be clarity on how the civil penalties are recovered by the "Issuing Municipal Official" especially in the case of waiver fees. As written, this wording implies that the fee might be paid to the Issuing Municipal Official.

Regardless of how a noise ordinance is worded, enforcement will be a continuing challenge

when dealing with complaints from people who are not reasonable and of ordinary sensitivity.

We do not want to have the Town Manager, the Select Board or the town's Justices of the Peace in the law enforcement business.

## ARTICLE VIII. EFFECTIVE DATE

The ordinance needs to be put to a town vote. An issue of this significance should not be decided by the Select Board under pressure from a small group of citizens, but deserves to be put to a town wide vote.

Dorset Selectboard Meeting  
August 17, 2017

I have 3 points that I would like to make at this meeting, the first now and 2 at the time the Noise Ordinance is discussed.

- For many years The Dorset Town Report has listed the meeting time and date for this board's monthly meetings as the **3<sup>rd</sup> Tuesday of the month at 7PM**. Tonight's meeting is the **5<sup>th</sup>** this year that has been changed. Should we expect this pattern to continue?

**Noise Ordinance**

- As I understand it, garbage collection, lawn mowing, snow removal, emergency response, etc. create unavoidable noise that can last for minutes but not hours. A neighbor's building project may be bothersome but is usually done during the daytime hours and a barking dog can be curbed by Animal Control.

The problem, as I see it, is **thumping/pulsating bass**, which is not music; **screaming/yelling**, which is not talking/laughing...and continues for a prolonged time. At one time we could count on Theron, Hal, Terry or Harold to intervene as they knew everyone and how to handle a situation, but those days are over.

**SUGGEST:** SB separate all events in **2 categories**—ones that last **1-2 hours** (they may have many people, music and alcohol) but there isn't enough anticipated time for it to become raucous. Those in the **3-6 hour** category have been planned for a long time, usually have well over 75 people and they are there to have a good time to the very end. If, however, the host was to remove the amplified music and/or alcohol factor, the party collapses. So, both are needed to insure a successful time...and the noise escalates. Neighbors are angry!

**Consider requiring PERMITS for 3-6 HOUR EVENTS (not to exceed 11PM)** which would include cost of sheriff, payable at least 30 days in advance of event. Sheriff has control and answers to selectboard not host.
